

Chemical Dependency Programs (CDP)

Current Statute requires that Auricular Acupuncturists operate only in a Chemical Dependency Program approved by DHS or by this Board.

However, DHS does not approve treatment programs and a prerequisite of licensure with DHS is that the agency must be Medicare-approved. As acupuncture is still viewed by Medicaid, Medicare, and most private insurance companies as complementary, integrative, or alternative medicine, it is generally not a covered service and so many of these agencies do not offer auricular acupuncture as a treatment option.

In light of the opioid epidemic that has become a serious public health concern nationally and here in the State of Arizona, the Board has decided to set forth specific criteria chemical dependency programs that wish to seek approval from the Board that can provide auricular acupuncture services through the employment of an auricular acupuncture certificate holder under the supervision of a licensed acupuncturist.

Nursing Board Advisory Opinion

The Arizona Nursing Board scope of practice committee has recently approved Advanced Practice Nurse Practitioners to perform "Acupuncture treatment to the appropriate patient population as outlined in [their] advisory opinion." The advisory opinion requires "Documentation of satisfactory educational requirements from an approved acupuncture training program"

The Advisory Opinion closes by stating: "Acupuncture can be safely performed by an APRN with specialized training, skills, ongoing training and knowledge in acupuncture thus ensuring patient safety and the use of acupuncture treatment protocols that are empirically based. The clinical discipline of acupuncture is practiced by a trained APRN who has met the criteria for both the General Requirements and Course of Instruction.

This advisory opinion CAN NOT be construed as approval for the APRN to use the title "Licensed Acupuncturist" as defined in A.R.S. §32-3923"

Legislation of Interest

SB-1062

Requires that the Board have an "Address of Record" for every licensee and certificate holder that may be disclosed to the public. You are also required to have an email address or phone number on file with the Board to be provided to a patient who is seeking medica records.

HB-2118

Requires the Board to regulate the unauthorized (unlicensed) practice of Acupuncture or Auricular Acupuncture and makes it a class 5 felony to practice without a license/certificate. It also provides requirements for the Board when an allegation of unlicensed activity comes in.

HB-2569

Creates a new "Universal Recognition" licensing path where an applicant who established residency in Arizona and who holds an active license in good standing in another state and who has never had a license disciplined may gain licensure here after having submitted license verifications and completing a Fingerprint background check and without providing all of the regular documentation for licensure such as transcripts, CNT Certificate, etc.

This legislation does not allow individuals from other states to work in Arizona without an Arizona License

SB-1086

Authorized the Board to issue a temporary license to a qualified individual to work in this state on a short-term basis for teaching a course, seminar or class, working during the process of receiving a full and active license, working while traveling with a sports or athletic team or providing free services during a declared state or national disaster.

Quick Tip

License Certificates are required to be posted in a conspicuous location in the reception area of your place of employment. When you receive your renewal notification stub by email you should cut out the small square with the updated expiration date and place it in the corner of your wall certificate to update the Certificate.

Did you Know?

R4-8-103. Change of Mailing Address, E-mail Address, or Telephone Numbers

Licensees and Certificate Holders shall notify the Board, in writing, within 30 days of any change of mailing address (giving both the old and the new address), e-mail address, or residential, business, or mobile telephone number. Failing to do so may result in an allegation of unprofessional conduct.

R4-8-502. Recordkeeping

An acupuncturist shall:

- 1. Make a complete, legible, and accurate record of each patient to whom an acupuncture treatment is given. The acupuncturist shall ensure that a patient record is in English and includes:
- Name of the patient,
- b. Patient history,
- c. Dates of treatment,
- d. Treatment given, and
- e. Progress made during acupuncture treatments; and
- 2. Maintain a patient record for six years after the last treatment of the patient or as prescribed at A.R.S. § 12-2297, whichever date occurs later.
