Complaint #2013-03 (Unprofessional Conduct) re: Qingsong Xiao, L.AC.

The Board received and reviewed the official complaint filed by Mr. Craig J. Klodzinski, the response to the complaint provided by Ms. Qingsong Xiao, L.AC., rebuttal letter provided by Mr. Klodzinski to Ms. Xiao's response and a letter from KeliAnne Kinnaird, former employee at Great Wall Chinese Medicine operated by Ms. Xiao.

Mr. Klodzinski addressed the Board and stated he sought treatments from Ms. Xiao for back pain. He received a bill for \$14,000 and questioned some of the charges and feels Ms. Xiao is practicing outside of her scope so this complaint has been filed. A complaint has also been filed with the Arizona Board of Massage Therapy.

The Board did not have a complete copy of Mr. Klodzinski's treatment notes so copies were made for review and discussion.

Assistant Attorney General Lee advised Board Member Adelman not participate in this discussion as he does not have a complete copy of treatment notes since he is participating via phone.

Board Member Martin stated the thirty-three pages of records are too much to read and would like to postpone this matter for later time.

The Board decided to gather information at this time and schedule this complaint for a future board meeting so Board Members have an opportunity to review the complete copy of treatment notes.

Mr. Klodzinski stated he informed Ms. Xiao that he didn't have money to pay her for her services and she replied that "he not worry about it at this time." At this time went on, Mr. Klodzinski reminded Ms. Xiao of his inability to pay Ms. Xiao.

Board Member Bronson asked when Mr. Klodzinski received word on his worker's compensation claim. Mr. Klodzinski stated a decision was not rendered until April 14, 2011.

Board Member Rhodes asked Mr. Klodzinski if he received treatments after the worker's compensation decision. Mr. Klodzinski answered in the affirmative.

Mrs. Klodzinski stated she reviewed the bills and noticed there was no record of some payments that had been made and questioned the accuracy of the payment records.

Assistant Attorney Lee suggested the Board request a complete set of notes from the first day of treatment from January, 2010 to October 17, 2011.

Board Member Gear asked if Mr. Klodzinski if any surgeries have been performed on his back and Mr. Klodzinski stated a number of procedures have taken place.

Mr. Klodzinski was asked to describe the ultrasound treatments he received at Ms. Xiao's office.

Mrs. Klodzinski indicated an effort has been made to negotiate with Ms.Xiao on payment, but no resolution has been achieved. The payment issue has been sent to a collections agency. In addition, Mrs. Klodzinski believes Ms. Xiao is practicing outside of her acupuncture license scope of practice.

Mr. Thomas Moring, legal counsel for Ms. Qingsong Xiao, reviewed the sequence of events leading to this complaint. Mr. Moring stated Mr. Klodzinski was provided with statements saying he is responsible for payments. A voice message (10/28/11) left with Ms. Xiao was played whereby Mr. Klodzinski states that he may have a way to pay Ms. Xiao through Hartford Insurance.

Mr. Moring reviewed the scope of practice for acupuncturists as it relates to the 62 treatments provided by Ms. Xiao.

The Board asked Ms. Xiao to describe the ultrasound treatments she provided to Mr. Klodzinski.

Board Member Martin moved to have this complaint scheduled for review at a future board meeting with Board Member Bronson providing a second. The motion carried by unanimous vote: 8-0.

### **Board Office Information/Activities:**

 Pursuant to Arizona Revised Statutes §32-3925 (B), license and certificate renewal notices for May 2013 licensees were prepared and sent. In addition, expired license and certificate letters for the month of February 2013 were sent.

- Completed and submitted the Aperture Credentialing survey. Aperture is a credentials verification organization that assists health plans with primary source verification of practitioners.
- Completed and submitted the Med Advantage Credentialing survey. Med Advantage is a credentials verification organization that assists health plans with primary source verification of practitioners.
- Completed and submitted the State Trip Reduction Program Employee Survey.

### **Budget Information**

• The Governor's office and the Legislature will begin budget discussions in the coming weeks. At this time, the Board's funding requests have been recommended for approval.

#### **Legislation**

Senate Bill 1037, introduced by Senator Nancy Barto, includes the Board's legislative recommendations as developed by the continuing education advisory and legislative advisory committees.

SB 1037 was approved by the Arizona State Senate on February 11, 2013 by a vote of 28 ayes and 1 nay and sent to the Arizona House of Representatives for action.

The Arizona House of Representatives Health and Rules have approved SB 1037 with unanimous votes. The Arizona House of Representatives Majority and Minority caucuses have approved the bill and the bill is awaiting committee of the whole action by the Arizona House of Representatives.

### **Call to the Public**

James Wagner, representing AMASA, provided the Board with a list of physical therapists practicing dry needling in the state. Mr. Wagner expressed his call for the Board to take action against these individuals. He would like to see this Board issue a cease and desist order to the people found on the list. Mr. Wagner believes physical therapists practicing dry needling are in violation of law and are endangering the public.

Jonathan Lindsey, representing the Arizona Society of Oriental Medicine and Acupuncture, asked the Board consider changing board rules of where auricular acupuncturists can practice. Mr. Lindsey indicated the Society is working on the dry needling issue, conducting town hall meetings, and herb sunrise proposal. The stakeholder meeting in Tucson was informative and well attended.

Steve Perlmutter, who has applied to the Governor's Boards and Commission office for appointment to a healthcare regulatory board, introduced himself to the Board. He is a retired Doctor of Ophthalmology and attorney

Board Member Adelman reported on the Arizona stakeholder meeting and thought it was a productive and informative gathering. The licensed acupuncturists provided professional presentations on the issue of dry needling.
