Roopali H. Desai, attorney representing the Coalition of Arizona Acupuncture Safety (CAAS), spoke to the Board regarding the unauthorized practice of acupuncture that poses a threat to the safety of the public. Ms. Desai also spoke to

the materials provided to the Board which states the position of the CAAS on the matter of dry needling as performed by physical therapists. Ms. Desai addressed her concerns with the claims made by the Ms. Munoz in Complaint #2014-01. Ms. Desai stated Arizona law is clear on the requirements to practice acupuncture via appropriate training. Ms. Desai described the action taken by the State of Arizona Board of Physical Therapy regarding the issue involving Ms. Munoz. She requested the Board to send a letter to the State of Arizona Board of Physical Therapy asking them to stop physical therapists from practicing acupuncture. In addition, Ms. Desai asked the Board to refer this complaint to the Yavapai County Attorney's office for review.

Professional Business

Update on activities regarding the topic of Dry Needling

Executive Director Gonzalez provided a summary of activities that have taken place in the past while addressing the concern of dry needling as practiced by individuals without proper training and authority.

The Board heard from a number of individuals regarding the issue of dry needling as performed by physical therapists.

Ms. Roopali Desai reasserted her concerns with physical therapists performing dry needling without statutory authority. She stated the Arizona State Board of Physical Therapy will not provide specific state language that demonstrates scope of practice authority for dry needling.

Theresa Ulmer and Laura Magnus from the Aarons Company provided the Board with a report on their activities on behalf of the Board. This includes visiting with policy leaders, health care professionals and other interested parties that share the concerns with physical therapists practicing dry needling.

Call to the Public

Y.M. Chen, L.AC., introduced seventeen members of the Chinese community and practitioners of acupuncture. Mr. Chen shared his thoughts on physical therapists using dry needling, practicing outside their scope of practice, minimal training and posing a public health risk.

Lloyd Wright, L.AC. stated consumers are in danger due to poor training and feels the public must have some confidence that physical therapists are trained. Mr. Wright feels the Arizona State Board of Physical Therapy has failed to regulate their licensees as it related to dry needling. He strongly urges the Board to protect the public since the Arizona State Board of Physical Therapy doesn't appear to be doing its' job.

Elyse Tera, L.AC., President of the Arizona Society of Oriental Medicine and Acupuncture provided an update on the organizations' new board of directors and fall conference—November 8-10. Ms. Tera stated no herbal proposal will be presented in 2014.
