Report by the Ethics Advisory Committee

The following report was presented by Board Member Wilks, Advisory Committee Chair

History:

On May 27, 2009, the Board identified a need to review options for identification of ethical standards established this Advisory Committee.

Process:

The Committee first did a survey of Arizona Health Care Boards, Various State Acupuncture Boards, and the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM), reviewing ethical standards.

The following options were identified:

- 1. Establish a freestanding code of ethics. This would provide standards to our licensees, but would not assist us in evaluating complaints of an ethical nature.
- 2. Pursue statutory changes, either by amending the Definitions of Unprofessional Conduct in A.R.S. §32-3901 (4), or by adding a code of ethics to statute.
- 3. Amend rules to clarify the above Definitions of Unprofessional Conduct (UPC).

The Committee has decided to pursue option #3, and evaluated each of the Definitions of UPC. Several legal issues were clarified by Assistant Attorney General Monty Lee.

Recommendation:

Finally, the Committee proposes clarification in rule of the following statutes:

A.R.S. §32-3901 (4) (i) - regarding the definition of "rebate", and

A.R.S. §32-3901 (4) (1) - specifying the NCCAOM Code of Ethics to be the "recognized standard of ethics of the acupuncture profession."

Input on these two points will be requested from the Assistant Attorney General in attendance at the January 26, 2011 board meeting. Our hope is to have rule modifications ready when the state rule-writing moratorium is lifted.

- Pursuant to Arizona Revised Statutes §32-3925 (B), license and certificate renewal notices for February and March 2011 licensees were prepared and sent. In addition, expired license and certificate letters for the month of December were sent.
- Completed and submitted to the Secretary of State's office, the Notice of Agency Ombudsman as required by A.R.S. §41-1006. The Board must annually report by February of each year the name of the ombudsman to be published in the state register. This requirement was previously required of agencies with over 100 employees, but the requirement now applies to all agencies, boards, and commissions.
- Completed and submitted the Biennial Renewal of Registration of Principals & Public Bodies for 2011-2012 pursuant to A.R.S. §§41-1232 and 41-1232.01. This information is maintained by the Secretary of State's Office.
- Reviewed, completed and submitted information to Med Advantage, a national Credentials Verification Organization (CVO), who conducts primary source verifications for managed care agencies and hospitals.

State Budget

• The Governor has recommended for the current fiscal year to transfer \$13,800 from the Acupuncture Fund to the general fund. In addition, \$10,100 will be transferred to the general fund in fiscal year 2012 which begins July 1, 2011.
