## **Presentation on Dry Needling**

An overview of legislation, as introduced by physical therapists across the country, regarding dry needling was presented by Ms. Mina Larson, Director of Public, Professional and Regulatory Affairs, National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM).

The Board reviewed the fact sheet prepared by the NCCAOM. Ms. Larson shared the position statement adopted by the Florida Acupuncture Board regarding dry needling and determined that dry needling is acupuncture.

The NCCAOM has been monitoring the dry needling issue for many years in order to inform the states on this practice by non-licensed acupuncturists.

Board Member Wilks referenced the NCCAOM letter whereby the organization highly recommends that physical therapists meet the same standard for education and examination that licensed acupuncturists must meet in order to practice safely and effectively in the state of Arizona.

Chairperson Bennalley asked if physical therapists are billing for dry needling. Ms. Larson stated that in some states physical therapists are billing using codes for intramuscular therapy but not for dry needling specifically.

Board Member Adelman asked why physical therapists couldn't adopt the same sort of training requirements to practice acupuncture similar to chiropractors currently practicing in Arizona.

Ms. Larson stated the NCCAOM is uncomfortable with the lack of education and training by physical therapists in the field of acupuncture. Questions on whether physical therapists have taken the clean needle training course have surfaced.

Board Member Adelman asked Ms. Larson for some information on what other states have experienced in addressing the dry needling issue.

Board Member Gear described the difference between electromyography and dry needling. Board Member Gear suggested using the term dry needling acupuncture.

Ms. Larson informed the Board that a certain dry needling education provider is actually teaching physical therapists acupuncture which further alarms NCCAOM as they attempt to protect the public.

The NCCAOM is aware and has information of some physical therapists practicing dry needling without any training whatsoever.

John Rhodes, PT, L.AC., reviewed the Fall 2011 Arizona Physical Therapy Association Conference whereby a dry needling course was made available to physical therapists. Mr. Rhodes stated that course participants are instructed not to use the term acupuncture and encouraged to make the distinction between the dry needling term and acupuncture. Furthermore, Mr. Rhodes is concerned with the lacking of training by the physical therapists while using the treatment of dry needling and insurance claims.

Executive Director Gonzalez provided an update on the four complaints against physical therapists that are practicing dry needling or without an acupuncture license.

Board Member Wilks reminded the Board to keep the interests of the public and not take a protective or turf position on the matter.

Susie Cannata addressed the Board to clarify the need for legislative authority for physical therapists to practice dry needling via sunrise legislation.
